Prior to game time the Am players will participate in a blind draw for a pro LM partner. To save time and avoid confusion, Non-Life Master players should bring a complete convention card to the event. The Life Master partner will play this card. As customary in Unit events, there will be hand records. To create a friendly atmosphere and put the players on a first name basis, players will wear name tags. Remember, this is a social event and not a time for lessons at the table. The Pro-Am in 2004 had 14 tables and the winners were Michael Fleisher and John Williams.

Pile Up Points at STAC Week

The biannual Western Conference Spring Sectional Tournament at Clubs (STAC) is back for the sixth year. All the clubs listed in the directory on the back page, except Easy Bridge, plan to sponsor STAC games the week of May 2-8. The awards are very generous so play and play and play for multi master points. Win and you get those shiny silver master points.

The District has changed the stratification from previous years. Strata C: 0-500 master points, Strata B: 500-1500, Strata A: 1500+. All players, no matter their ranking, look forward to the good and exciting competition at STAC games, so plan now to play a lot. Obviously, the more you play, the better the chances for bigger point stacks.



Ethics by Gersh Wheeler

If your partner makes a bad bid or play, it is unethical to pick up the duplicate board and hit him, regardless of the vulnerability. Lest you think I'm being facetious, be aware that on many occasions players have come to blows, and at least two murders have been committed as a result of arguments at the bridge table.

When the ACBL was formed in 1937, one of the first considerations of the board of directors was how to handle unethical behavior. This led to publishing a list of things that were unethical. Then came a list of things you should do to welcome your opponents. Over the years, these lists got longer, but unethical behavior is still a problem. Basically there is only one rule of ethical behavior: **DON'T DO ANYTHING THAT YOU WOULD RESENT IF YOUR OPPONENT OR PARTNER DID THE SAME THING.** Does this sound like the Golden Rule? Well, why not!

Closely related to ethics, but not really part of the same problem is the desire to make your opponents feel comfortable. The ACBL doesn't want to lose members who might quit if they don't enjoy the game. But how far do you go to ensure their enjoyment? If you bid badly and give your opponents a top, they might enjoy it, but obviously, the ACBL is not suggesting that you do this deliberately.

These are some things that can and should be done. Some are even specified in the laws of the game, but are frequently neglected. For example, the laws state that every player must have a convention card, properly filled out, on the table. Unfortunately, many players don't bother to fill out a card. Even when they do, I find it difficult to read my opponent's card when she's sitting on it.

If you would like your opponents to be friendly, make it easier for them to do so. PRINT your name on your card, and maybe next time you come to their table, they will greet you by name. If you have a name tag, wear it. This encourages friendship.

Remember, it's still a competition. If your opponents make an error, such as an insufficient bid, it is perfectly legitimate and not unethical to take advantage of it. But it's also still a game to be enjoyed in a friendly atmosphere. If your partner makes an error, don't punish him by overbidding on the next hand. Players make mistakes, mainly, because they are not very good players. There are very few really good players, just as there are very few really good doctors, teachers or plumbers. Even though you always play perfectly, don't expect perfection from everyone else. Was the game created for man, or was man created for the game?

More Points to Ponder re Ethics/Conduct:

- 1. It is appropriate for one to compliment the opponent's bidding or play at the table. One should compliment one's partner in private.
- 2. Pass boards in a timely manner and, if running late, give a board to the next table so that the next table will not have to come and get it from you.
- 3. If you are the first to lead, play a card, then write the contract onto your score sheet. Save detailed conversations about a hand until after the session is over.
- 4. Don't snap your cards on the table or flip them on the table.
- 5. Don't read out loud the results of a board, or make comments such as "top board for us". Other tables near you can hear and the opponents can find out they got a bottom board without your saying so.
