# Profile on Sherie Greenberg

When I started playing duplicate bridge, every maxim I heard began with the words: "Sherie says.." And every question about the game started with "Let's ask Sherie." Teacher and guru for so many of us, Sherie has had a profound effect in bridge circles—locally and nationally. A diamond life master, she has been a national winner of the Women's Board-a-Match event; she has won the national Goodwill Award; and she is in the Encyclopedia of Bridge. Locally, she has three games: Mondays and Wednesdays at the Bridge Club, and Thursdays at Cubberley. She is especially known for her dedication to newer players. She says she loves, most of all, teaching beginners.

Bridge came naturally to her. She grew up watching her parents and aunts and uncles playing the game. There was a duplicate game in her high school. One summer she and a friend went to a duplicate game at a more professional club. The girls kept bidding and bidding—and going down. So they decided not to bid for a while. When their opponents discovered that both of them had opening hands and had not bid, they called the director. Only after being informed that Sherie was the daughter of a champion, Clara Rickel, their demeanor turned to respect.

Sherie says as a young woman she didn't really know how to play or defend, just kept trying to figure it all out. Not until she read Eddie Kantar's books did she find a clarifying description of what she had taught herself.

Born in Allentown, Pennsylvania, she attended Penn State and Boston University, majoring in communication arts. After graduation, she moved to New York. There she worked as a showroom and runway model. But, she wanted to live in California. So David, an aeronautical engineer from MIT, whom she had met in Boston, and who had courted her for five years, got a job at Lockheed. They married, moved to California, had two daughters, Morisa and Stephanie. And Sherie fit in bridge whenever she could. The YWCA in Palo Alto had duplicate games—and child care (for 50 cents an hour)—which kept her involved. And when the "Y" wanted a bridge teacher for their seniors, Sherie was available. Each senior paid 50 cents, and received not only Sherie's instruction, but the refreshments she furnished as well. And, when someone at Oak Creek heard Sherie described as "the best bridge teacher on the Peninsula," although she was terrified, she began teaching there. She has taught everywhere on the Peninsula, and for many years wrote a bridge column for the *Palo Alto Times*.

Tournaments at first scared her, so much so that the rickety card tables of the time shook along with her. There was much screaming and yelling—no zero tolerance then—but she stuck with it. Sherie especially didn't want anyone to tell her who the experts were, preferring to play against anonymous opponents.

As for her philosophical views of bridge, Sherie considers defense 75% of the game.

Bidding should be logical. She opposes a whole lot of new systems, considering them fads. She believes she gets many of her top boards from opponents confused with their own bidding. She remembers playing with Richard Spitalnik, when he insisted they bid 4-card majors. She went along with him, and they *did* win the mixed pairs in the sectional, but soon he came back to her point of view. "Partnerships are not marriages," she says, and urges players to vary partners frequently. "Although one can learn from a disagreeable partner," she says, "you're asking for it, and must go along pleasantly!" Always agreeable herself, always ready to help the Unit, always ready to answer questions, always ready to get a newcomer to share her passion for the game, Sherie has been of immeasurable value to the Club and to bridge itself. I still hear "Sherie says." and "let's ask Sherie." Yet she says, "Bridge has done more for me than I ever did for it."

Usually, when a player makes an insufficient bid, someone says "insufficient," the offender corrects the bid and no one objects. But, someone may have been hurt and the Laws of Duplicate Bridge do provide relief.

First, the left-hand opponent (LHO) of the offender has the right to accept the insufficient bid, no matter who called attention to the irregularity. If the LHO doesn't notice the insufficient bid and makes a call (bid, passes or double), the insufficient bid has been accepted and there is no further penalty. Why would you accept an insufficient bid? Here are some examples from actual play.

- (a) I opened the bidding 1S. Partner bid 1NT and my RHO bid 1H. I accepted the insufficient bid and bid 1S, thus showing a rebiddable suit at the one-level.
- (b) My partner opened the bidding 2D. I bid 2NT and he bid 2H. My RHO passes, thus accepting the insufficient bid. I now bid 2NT again. In both these cases, I had to borrow a bidding card from someone else's bidding box.

If the LHO of the one who makes the insufficient bid does not accept the bid, the offender must correct the fault, but cannot double or redouble. The correction must be a bid at a sufficient level or a pass.

If the insufficient bid was not an artificial convention and if the minimum sufficient bid in the same denomination (suit or NT) is not a convention, the offender can bid the lowest sufficient bid in the same denomination and there is no penalty. If the offender makes any other bid or passes, the offender's partner must pass for the rest of the auction.

If the insufficient bid was a convention, offender can pass or bid anything else, but again offender's partner must pass for the rest of the auction.

If the offender's correction is not in the same suit as the insufficient bid, there is a lead penalty if offender's side becomes defenders. In general, declarer can require or forbid offender's partner to lead the suit names or indicated by the insufficient bid at the player's first chance to lead.

## It Seems to Me

While playing in the club games, I get many tops. I would like to say that this is due to my superior bidding or play, but in truth, most come from my opponents' errors. Their most common fault is failure to recognize a forcing bid. So here are some common bidding sequences. Your problem is to determine if the last bid in each example is forcing, invitational, or sign off.

- 1. Partner opens 1H.You bid two clubs. Partner bids 3H.
- 2. Partner opens one heart. You bid one spade. Partner bids 2 clubs. You bid 3 spades.
- 3. Partner opens 1H. You bid 1S. Partner bids 2D. You bid 3C.
- 4. Partner opens 1H. You bid 2C. Partner bids 2D. You bid 3C.
- 5. Partner opens 2H. You bid 3C.
- 6. Partner opens 2H. You bid 2NT. Partner bids 3C. You bid 3D.
- 7. Partner opens 1D. You bid 3NT. Partner bids 4D
- 8. Partner opens 1NT. The next player bids 3C. You bid 3S
- 9. Partner opens 1S. Next player bids 3C. You bid 3S.
- 10. Partner opens 1D. Next player bids 1S. You bid 3C.

I play with many different partners and they have different answers to these problems. For the most part I go along with them. Thus, there are no correct answers. The important thing is that you and your partner agree on the meaning of your bids.
