PALO ALTO UNIT MAINTAINS GROWTH

The Unit added 28 new members, 3.8 % from October 2006 to October 2007. Although this increase is smaller than the 46 added last year, it is still significant. The Unit owes this increase to the efforts of the Board members, the Education committee members, the club owners and directors and the Unit members.

The ACBL October QUIP reports the following information. In the last 12 months, the active membership increased 3.4%, the new membership gains were 7.5% and the member losses 4.2%. In these three categories, the Unit ranked 7th, 8th and 7th respectively among the 20 District 21 units. Both the average member age and the average years of ACBL membership remained at 67 and 19, respectively

Gary Macgregor leads the masterpoint list with 6903, followed by Don Rothschild 6742, Sherie Greenberg 6708, Jim O'Neil 6115 and Ashraf El Sadi 6000. The player closest to the average masterpoint is Sherman Maisel with 534 and Ted Aberg is at the median with 136.

Each October the ACBL issues a Unit membership list. An Excel spreadsheet version is the source of the information in this article. The table at the right compares the masterpoint distribution and other information for members for 2007 and 2006 from analysis of the ACBL data

It Seems to Me

When your partner opens 1NT and the next player passes, you usually have no difficulty getting to the best contract. But if your right hand opponent doubles or overcalls, it raises problems. How do you indicate enough for game or simply a desire to compete for a part-score? How do you tell partner you have a stopper in the opponent's suit?

There are many methods of coping with the interference, such as doubles, cue-bids, and the Lebensohl 2NT. You should discuss with your partner what each of these mean and when to use them.

If you bid 2 of a suit over the interference, it is weak, to play. If you bid at the 3 level, it is a force to game. Here are some ideas about what to do, but these are suggestions, not rules.

- 1. With enough for game and a stopper in the opponent's suit, bid 3NT. With enough for game and no stopper, bid 3C. If opener has no stopper, you will have to scramble at the 3 level to find a fit. Note that the 3C bid can also indicate a desire to play at a slam in clubs. In that case, you will bid further if opener bids 3NT.
- 2. If you have a 5-card major and enough for game, you might prefer to try for game in the major. Bid three in your major if you have a stopper in the opponents suit; with no stopper bid 2NT. This is Lebensohl and asks opener to bid 3C. Then you bid 3 in your major. I prefer the direct 3 bid to show a stopper and the Lebensohl sequence to deny a stopper, but obviously you could play it the other way around.

- 3. If the overcall is 2C, it is not much interference. A simple approach is to play that a double is Stayman, and all other calls have the same meaning they would have without the overcall. If you use this method, then a bid of 2NT after the 2C overcall is *not* Lebensohl
- 4. If the overcall shows 2 suits, then a cue bid in one of the suits shows a stopper. With stoppers in both, bid 2 or 3NT, depending on your strength. Here again the 2NT bid is not Lebensohl.
- 5. If the opponent doubles the NT bid, you can bid Stayman and transfers just as without the double. With a weak hand and a long minor, you can redouble. This asks opener to bid 2C, so that you can get out at two in a minor.
- 6. If you pass the double, you are asking opener to redouble. The pass shows 2 possible hands. One, you are willing to play at 1NT redoubled. Two, you have 2 weak suits. In the first case you pass the redouble. In the second case you bid the lower ranking of your two suits, and then scramble to find a fit.
- 7. A cue-bid of the opponents' natural overcall of two in a suit other than clubs could be used as Stayman. But it could also be used as Michaels. Discuss this one with your partner.
- 8. A double of the overcall could be for penalties, negative, or a shadow double. Discuss!

If all this sounds too complicated, don't try to adopt it in one sitting. Choose one or two ideas you can live with. When they become familiar to you, add others one at a time.
