The July calendar has two NAP qualification matches, both on Wednesdays. The Bridge 'n Brunch has set July 14 at 11 a.m. and the Doubleton Club, July 21 at 7 p.m. Players who place in the overalls in their respective strata earn sectional-rated half red and half black masterpoints. Any player scoring average or higher or finishing in the upper half will be eligible for the next qualification round (see the June Forum, p. 1).

On Sunday, May 20 the Unit Swiss Teams again scored with 18 teams in the open flight and 7 in the 199er. In the open, Sherie Greenberg's team including Jim O'Neil, Don Rothschild and Tahir Gokcen had a huge win averaging over 17 out of 20 victory points per match. B strata winners were Barbara Dahl, Steve Conaway, John and Susan Wachsman. In the 199er flight, the team of Joe Buchanan, Joy Barrett, Robert Bergey and Shirley Streifer triumphed.



We doubtless can thank the Spaeths for our pleasant, happy President, Mike Atherton. One day at Michael's restaurant Mike ran into Grant Spaeth, who suggested they start playing bridge together. And why did Grant suggest that? It was "Because his wife told him to get another partner." Every Tuesday since, (well, *almost*) Mike has been playing with Grant.

And as if that weren't enough, Mike tells us, "Lori put me on the Board." Soon after, Mike "inherited" the presidency and consequently "inherited" the flood. That has been a continuing problem for him, as the air quality continues to be monitored and as he looks into other possible locations. He has our welfare in mind as he bears the burdens of the presidency, always with a twinkle in his eye.

Born in South Africa, the middle son of three boys, Mike came to the US when he was three and spent his youth in Hollywood, where his stepfather worked in classical music. From the ages of five to ten he attended a Catholic military boarding school—and hated it—and then went to a "serious" high school in West Hollywood for Jesuit preparedness. At UCLA he majored in English Literature, and then came to Stanford Law School.

After a year of law practice in San Francisco and a stint as City Attorney in Mountain View, he went into private practice, specializing in eminent domain cases. When the town of Alviso flooded in 1980, he sued on the town's behalf the city of San Jose and the Water District. (Are floods following Mike around?) That case ended in 1989, with a big settlement for all the clients—and a triple bypass for the attorney.

So when did he have time to play bridge? He used to spend "working vacations" in Palm Desert where he could make court appearances by telephone; that left him time to get started at social bridge. His teacher was his wife, Marcella, whom he had married in 1983. With his first wife, who had died in 1976, he had four children; they and six grandchildren all live in the area. Recently, the grandchildren clustered around his swimming pool where a duck is mothering nine babies, hatched on May 3.

In 2003 Mike retired as an attorney. While his wife was recovering from a knee injury, Mike managed to fall while playing tennis. "Are we going to have to put up two hospital beds in here?" she asked, and that called for his retirement from tennis.

Now it's bridge and movies and travel—two very special months in Italy recently. And after many other trips to Europe, he's looking forward to a trip to Ireland—"part of my background." He loves our bridge club, "It is great, with good friends; people who don't take the game as life and death." And he loves the game itself, "The intellectual challenge is endless; the combinations of cards are mind boggling."
