At the Unit Game on Sunday June 20, the Unit will hold a special meeting to make revisions to the Constitution. The Unit requests that the Unit members present vote to *accept* the proposed changes. The purpose of these revisions is to simplify the Treasurer's job which currently necessitates maintenance of two bank accounts, one for the Unit and one for the Bridge Center and which requires writing checks to transfer funds in and out of each bank account. The proposed changes would eliminate one account but the Treasurer would keep separate books, one set for Unit income and expenses and the other for Bridge Center income and expenses. 

Study the Scores with Bridge Composer



For an increasing number of Unit 503 club games, directors are posting a new feature made possible by a program called "Bridge Composer," along with the usual recaps and hand records on the Game Results page on the Unit website. On the "Game Results for _____(month) page, look for a "C" associated with the game in which you played, click on that (C) and scroll down to the first board. Do not click the name of the game as you normally would. As you can see in the sample below, it gives you the hand, the makeable contracts and the results for each pair sorted by rank from the N/S perspective. (We changed the names to protect the innocent.) If there are multiple sections, they are separated by section and then ranked. This is a great learning tool!

Continued From Page 1, Constitution Article XIII Section C

The Treasurer shall have care and custody of the funds of the Unit and the Bridge Center. He shall disburse money for the business of the Unit and the Bridge Center as authorized by the Board. He shall keep an accurate account of all receipts and disbursements and shall submit a financial report at each meeting of the Board of Directors. He shall deposit all funds of the Unit in bank(s) designated by the Board. He shall deposit all Bridge Center funds in a separate account.

Article XV, Section E

2. The Treasurer shall have care and custody of the funds of the Bridge Center. He shall receive and disburse money for the business of the Bridge Center. He shall keep an accurate account of all receipts and disbursements and shall submit a financial report at each meeting of the Board of Directors. He shall pay all bills and deposit all funds related to the Bridge Center in a separate account. Such funds shall be kept separate from the Unit funds.

Players who place in the overalls earn sectional-rated half red and half black masterpoints. Any player, who scores average or in the upper half in their respective strata, will be eligible to play in a two-session Unit final to fulfill the requirements for the District matches. The masterpoint strata are: A (unlimited), B (0-2000), C 0-500 (Non-Life Masters).


