

Bridge Center Rehab - Tests conducted at the Bridge Center during the Regional indicate that nearly every opened wall showed visible mold growth. However, recent air testing confirms that the mold is contained within the walls and is not affecting the air quality in our facility. Soon, a meeting will address the time, manner and extent of the rehabilitative work necessary. This will require temporary closing of the Bridge Center. The Unit will notify members regarding the timing of the work and the replacement location (s) of the games. The BC is safe to occupy until repairs are made.

Constitution - At a meeting on August 29, Unit members approved changes to the Unit Constitution allowing the treasurer to maintain one bank account for the Unit and Bridge Center funds. The treasurer will continue to keep separate financial records for each entity.

Bridge Bits



It Seems to Me

The better players are so accustomed to look for advanced plays like squeezes or end plays that sometimes they miss a simple declarer play. Here is a problem hand with no advanced play re-

quired. **North**

S: 53

H: KQ43

D: KJ53

C: Q108

South

S: AK6

H: J52

D: Q62

C: AKJ2

You, in the South seat, are declarer in 3 NT. The opponents have not bid. West's opening lead is the spade queen. How do you play the hand?

A simple analysis shows you have four club tricks and two in spades. You need three tricks in the red suits. Assume West has at least four spades. The red suits do not split three-three. The

red aces are split, each opponent holding one.

I showed this problem to about 20 players; all ducked the first spade and took the second. Now almost all of them led a red two. This has a 50% chance of winning. It wins if West has the ace of that suit. But if East wins the third trick, he will lead another spade after which West still has an ace to continue spades and set the contract. Thus it is important to lose the lead to West's ace before East's. In this way East will be out of spades when she wins her ace.

The correct play wins 100% of the time. For the third trick lead a club to dummy then lead the diamond three toward the South hand. If East has the ace and takes it, you have three tricks in diamonds; if East doesn't take the ace, your queen wins. Then you shift to hearts to win two more tricks, making three in the red suits. Finally, if West has the ace of diamonds, you have succeeded in losing to West's ace before East's. Obviously you could have led the other red suit from dummy. Too simple!
