FIRECRACKER FEE INCREASE

The Board decided early this year that entries for the 2015 Firecracker will be \$12. This article explains the reason for the increase.

Last year we made approximately \$3000 with an \$11 entry fee on a near record attendance of 1,042 tables. If we keep the \$11 fee this year, we would break even with an attendance of 1,000 tables. The Unit is on a good financial footing so we don't need to make a lot of money on the tournament. Rather, the objective is to make as much as the Unit loses by closing the Bridge Center during the Firecracker.

However, our risk has increased substantially because of Levi Stadium. If there is an event at the stadium during the tournament, parking at the Convention Center is not guaranteed, and attendees may be asked to pay for the parking that is available. This could have a disastrous effect on attendance. The decision to increase the entry fee was made because of the increased risk.

I spoke to Pam Hughes, the D21 Tournament Manager, at the Burlingame regional to ask her how they were able to keep the entry fee at \$10. It's all about guaranteeing revenue to the hotel by booking hotel rooms. D21 guaranteed approximately 1100 hotel nights during the regional, enough to mean that the district didn't have to pay for the playing space. We have trouble guaranteeing 80 rooms for the Firecracker, so we pay for the playing space.

Pam is having difficulty keeping costs down as hotels increase their demands. The Burlingame Hyatt is a good example. The Hyatt cancelled the contract they had with D21 for 2016 even though they had to pay a considerable fee to do so.

A committee has been formed to explore 2016 Fire-cracker options. The options include alternate venues and downsizing. If you have ideas for the committee to consider, please contact James Stuart-Smith, <u>jstuartsmith@att.net</u> or Jody Williams, <u>jody@hamilton.com</u>.

BOARD ENCOURAGES COURTESY

At its March 10 meeting the Board focused on several issues related to courtesy to other players.

First, several players have reported that they have allergic reactions to fragrances and asked whether our Center could become a *fragrance-free* facility. The Board would like some input from the membership on this issue and will conduct a survey. In the meantime, the Board voted to encourage players to attend fragrance-free as a courtesy to other players.

Second, an old but ongoing issue. Players who are ill and may be contagious should stay home and avoid exposing other players. *No exceptions*. Individual directors are responsible for enforcing this on a case-by-case basis, but players must be responsible for their own conduct.

Third, concerning parking. For legal and financial reasons, the Board is not able to add official handicapped parking spaces. Instead, the Board encourages players to leave the spaces nearest the doors available for those with impaired mobility. We are investigating signs designating several of these spots as "Courtesy Spaces." These signs will have no legal standing, but will serve as a reminder that a number of our players do have mobility issues.

Fourth, another old story, is clean-up. Players are responsible for returning their final table to its original condition. Period. No trash, no cups or mugs or water bottles left behind; no pencils on the floor. In a typical game with 20 tables, directors report 30 or more cups or mugs left sitting on the tables. Let's let our directors focus on bridge rather than cleaning up our messes. The Bridge Center belongs to all of us; we should treat it with some pride of ownership.

In other business, the Unit's cash flow is close to budget. Fees from February games were down compared to last year, but the Burlingame Regional was in February this year. Last year it was in March, so March results may offset that decline.



Reminder: the dates for our Super Sectional, the Firecracker, are June 10th through June 14th. All tournament details and schedules are posted on the unit website and on the ACBL website. We are still looking for volunteers to help with Hospitality, Partnerships, and Set up and Take down. Thank you to all of you who have offered to help so far. Which Game Should You Play In?? By Merri Banks

When you are a newcomer to duplicate bridge, you have a lot on your mind – bidding conventions, defensive signals, declarer play, competitive bidding and so on. But before you can even start, you have to choose which game to play in. Unit 503 offers a plethora of choices – but which one is right for you? Only you can answer that, of course. But so here's a guide to help you understand how the different games provide options to you and your partner.

First, you should understand that there are two basic types of games: open and restricted. An open game is easy to understand – it is open to all. Restricted games, though, can be restricted in a variety of ways, at the option of the game manager.

On the Unit's Game Schedule, there are two types of restricted games listed. One type is Invitational – that means it is restricted to members of the sponsoring organization and invited guests. You will know if you can go to those games. The other more common restriction is based on the number of masterpoints accumulated by the players. The game director has the discretion to apply the restriction to either the individual player's total masterpoints or the average of the pair (or team). If you have very few masterpoints, playing in a game that uses pair or team average could expand the range of your choices for a partner.

For most of the regular games, the higher-ranked player's total is used to determine eligibility and also for stratification purposes. Special games may have different eligibility rules, but those rules are usually well advertised. STAC (Sectional Tournament at Clubs) games use the pair average for strat purposes. The game manager also has some discretion in allowing non-eligible players to partner with an eligible player in certain circumstances, although that pair then cannot be ranked for an award.

So how do you know which rule applies? If it isn't apparent and you are in doubt, you can just ask the game manager. Contact information is provided on the game schedule.

The Unit 503 Board is currently looking at ways to provide this information clearly on the website.

Intimidation 101 in Bridge by D.K.

Some days I come to the club just to watch. While looking for an "interesting" table I heard the following dialog: (North) "Partner, please don't claim." (South) "I am claiming." (North) "please don't..."

South a Grand Life Master spreads the hand on the table saying, "I have the rest of the tricks" and gives a brief explanation (7 cards remaining to be played). West (a relative novice) says, "I cannot visualize the play of so many cards, but you are a very good player so I believe ..." The cards are put back in the board.

Is this OK? I don't think so. If the opponents don't understand the claim, play should continue and South needs to put the cards face up and play card after card until the play is completed. This would create a win-win situation: by explaining the claim, S would teach E/W something about the play of the cards. And E/W will learn something and feel better about the claim.

In general, no matter how good a bridge player you are, *don't hesitate to decline a claim* if you have *any* doubt about the correctness of the claim.

While several of us were waiting for the game to start one fellow told the following story about a claim:

The opponents' contract was 3S. With seven cards left, East, a Gold LM, lowered his hand and claimed the rest of the tricks.

Infraction #1: No line of play was mentioned. Infraction #2: A trump was still outstanding. South, holding the missing trump, could now see three hands and figured out that there was indeed a double dummy way to make the hand, but it was too complex for a claim.

Infraction #3: South did not claim the trick but asked E to state a line of play.

Infraction #4: E picked up the hand (once a hand is tabled it cannot be picked up) and then committed:

Infraction #5: E took a finesse which lost (once you claim you cannot take a finesse)

Infraction #6: E claimed "down 1" (there still was a trump outstanding).

So, again, don't be shy when opponents claim. Review it carefully and if you have the slightest doubt, ask for the line of play; it is your right. Call the director if your questions aren't satisfied adequately.

Continuing my walk I find what looks like an "interesting" table (this is not a joke). Everyone at the table was at least a Silver Life Master. West opened 1H, North overcalled 1S, East bid 4H, South bid 5C. West and North both passed. East bid 5H and South bid 6C. Then everyone passed. West's hand was xx, AKQxx, xx, QJxx. The result was down 3. Why did West not double?

After the game I approached E (W had left already) and asked why did W not double. The answer was: W was afraid that N (a top player) will run to a different suit. What???

This is another kind of intimidation, self-intimidation. Even if N/S were Charlie Goren and Helen Sobel, there is no way any slam would make.

A top woman player, who always won her class Gold LM master point competition, was asked her secret for winning. She responded, "I love the game and play at least two sessions a day. When I sit down to play I take out the "red card" and put it near my bidding box to tell opponents that I will double any time they over bid."

The basic guide line for doubling is that *if the oppo*nents don't make **two** of **six** doubled contracts, you aren't doubling enough.
